A RESOLUTION

1 Designating the month of October 2010 as "Realtors Reach Out
2 Month" in Pennsylvania.

3 WHEREAS, The Pennsylvania Association of REALTORS® and its 48
4 local associations are participating in REALTORS® Reach Out 2010
5 across this Commonwealth; and

6 WHEREAS, This is the third year that REALTORS® will be
7 participating in this initiative; and

8 WHEREAS, From October 1 through October 31, REALTORS® will be
9 volunteering their time to benefit charitable organizations; and

10 WHEREAS, Pennsylvania REALTORS® volunteer throughout the

1 year, but the Pennsylvania Association of REALTORS® and its
2 members want to make a concerted effort to help out in
3 communities across this Commonwealth during October 2010; and

4 WHEREAS, In the past two REALTORS® Reach Out events, more
5 than 4,700 REALTORS® across this Commonwealth participated with
6 27 local REALTORS® associations and boards, donating more than
7 \$101,000, collecting nearly 18,000 pounds of food and 1,000
8 pieces of clothing to charitable organizations; and

9 WHEREAS, Members also have refurbished homes, cleaned up
10 local communities and held auctions and blood drives as part of
11 this initiative; and

12 WHEREAS, The Pennsylvania Association of REALTORS® is a trade
13 and professional association that serves as the "voice for real
14 estate®" for its more than 30,000 members in this Commonwealth;
15 and

16 WHEREAS, The association enables its members to transact
17 business to the advantage and protection of the public and its
18 members and also promotes and maintains high standards of
19 conduct; and

20 WHEREAS, The members of the association are dedicated
21 professionals who advance community development and economic
22 growth, protect private property rights, work for economy and
23 efficiency in government and volunteer their time and talents to
24 a variety of charitable organizations in this Commonwealth; and

25 WHEREAS, The association works with the Pennsylvania State
26 Real Estate Commission and the State Board of Certified Real
27 Estate Appraisers in the enforcement of regulations relating to
28 the profession; and

29 WHEREAS, Originally chartered in 1920, the association is one
30 of the largest trade associations in the State; therefore be it
